- We will limit the number of same products. (The committee will also make sure that vendors are not placed next to each other that are selling similar products)
- The Freedom Fest Committee reserves the right to accept or deny any exhibit based on the photos submitted. All decisions are FINAL. We also reserve the right to refuse space to any exhibitor who does not comply with these rules. Any exhibitor not complying with rules and/or conducts themselves in an unprofessional manner will be asked to leave the grounds.
